Founded and managed a publishing company headquartered in Chicago, Illinois. At its peak, Ebony magazine had over 2 million copies in circulation per month.	John H. Johnson
Founder of the Greenwood district in Tulsa, Oklahoma.	Ottaway W. Gurley
Made a fortune creating and selling hair care products.	Madam CJ Walker
His fortune started with burial insurance.	AG Gaston
The first African American to appear on the Forbes 400 list.	John H. Johnson
Martin Luther King Jr. stayed at his hotel in Birmingham, Alabama.	AG Gaston
Founded a business school with his wife called the Booker T. Washington Institute.	AG Gaston
Hosted what is believed to be the first national gathering of women entrepreneurs to discuss business in the summer of 1917. Two hundred women attended.	Madam CJ Walker
